Calling all Crafters for a New Campaigns Project: WI Women in Activism


The NFWF Public Affairs team would like to invite WI members to take part in our new craft project 'WI Women in Activism'. The project involves creating

procession banners or pennant flags, with the aim of featuring them in an NFWI online exhibition to mark International Women's Day in March (8 March 2021) and using them in any future marches we attend once Coronavirus restrictions are lifted.

Whilst the deadline for projects to be used in the online exhibition is 5th March (for International Women's Day), we do appreciate that some members will wish to spend more time on this. Every twenty minutes, someone in the UK is diagnosed with blood cancer. A blood stem cell donation from a matching donor could save their life. Siblings are the most likely to match your tissue type, however between 65% and 75% of people who require a blood stem cell donation are unable to find a sibling match.

In the UK, only 2% of people are registered as stem cell donors

The WI is working with DKMS and Anthony Nolan to increase the number of people on the UK's aligned stem cell registry, to help make more life-saving matches.

Environment Bill Report Stage

On Tuesday, 26th January, the Environment Bill returned to the House of Commons for its Report Stage.

Together with Friends of the Earth, Surfers Against Sewage, Keep Britain Tidy and Tearfund, the NFWI has been working to build support for an amendment to the Environment Bill which would place binding plastics reduction targets into the Environment Bill.



Our amendment was tabled by Chris Loder MP, supported by the Conservative Environment Network, and by a number of cross-party MPs. It also received national and regional coverage, including a mention on Radio 4's Today programme.

Although our amendment was not adopted by the Government, DEFRA Minister Rebecca Pow reiterated the Government's commitment to plastics reduction, and gave specific reassurances that measures in the Environment Bill are already sufficient to tackle the problem.

Whilst the NFWI appreciates Rebecca Pow's support and work in this area, we will be continuing our work with Friends of the Earth, Surfers Against Sewage, Keep Britain Tidy and Tearfund to strengthen existing measures in the Bill in order to combat the plastic problem.

This will include working to boost awareness of the Plastic Pollution Bill tabled by the Liberal Democrat MP, Alistair Carmichael MP- the 'gold standard' of plastics reduction measures- and adding further signatures to our **joint letter to the PM**, written in support of binding plastics reduction targets in the Environment Bill. We will also be working to build support for our amendment

amongst Peers in the House of Lords.

The NFWI is very disappointed that the Government has further delayed the next stage of the Environment Bill by a further six months. In one of the most important years for climate action for the UK, leaving an environmental governance gap does not demonstrate the climate and environmental leadership that we need to see from the UK Government, and the NFWI urges the Government to reconsider this decision.

APPG on Microplastics- Virtual Roundtable on Microfibre Filtration

The latest meeting of the All-Party Parliamentary Group on Microplastics was hosted on the 19th of January. The meeting explored the recent French legislative proposals on washing machine filters- requiring all new washing machines to include embedded microplastic fibre filters by 2025- and whether or not this could be feasible in the UK.



The APPG meeting was attended by 9 appliance and washing machine filter companies, world-leading academics specialising in microplastic fibre release, industry and retail groups, environmental organisations, MPs and Peers.

Following the meeting, all attending stakeholders have been asked to submit their policy positions on microfibre filters by the **5th of February 2021**.

As the APPG's Secretariat, the NFWI will be analysing all responses received and will use these to produce a report on microfibre filtration.

The Chair of the APPG on Microplastics, Alberto Costa MP, also drew attention to the work of the APPG in a recent **parliamentary business question**.
